

BACKGROUND

Our PGY2 Critical Care Residency Program is a comprehensive program, with a base location at Sharp Grossmont Hospital. The PGY2 Resident will have an opportunity to gain hands-on clinical experience in interdisciplinary team-based care in multiple diverse patient care settings. Unique to this program is the diversity of learning experiences that will offer invaluable opportunities for professional development in areas including, but not limited to: MICU, SICU, emergency medicine, trauma, advanced heart failure, infectious diseases, and operating room. Residents will also obtain a teaching certification, precept students, and be given the flexibility to personalize the residency experience to meet their career goals.

In this residency, the resident may gain experiences at any of our four acute care hospitals.

Sharp Grossmont Hospital is a 524 bed facility and the home site for the PGY2. It is located in East San Diego County. It is the largest not-for-profit, full-service acute care hospital in the region with 542 beds. The hospital's Emergency and Critical Care Center is among the most technologically advanced in the nation. It is home to one of the busiest emergency departments in California, serving 105,000 patients annually, with 24/7 ED pharmacist coverage. The Burr Heart and Vascular Center, a Comprehensive Stroke Center, offers more advanced cardio and neurovascular procedures. Sharp Grossmont is a nationally recognized MAGNET®-designated hospital for nursing practices.

Sharp Memorial Hospital is a 656 bed facility in San Diego and located on our Sharp Metro Campus. As a level 2 trauma center, it has been recognized as a Magnet® hospital for nursing and patient care excellence and is known for its transplant program where the first heart transplant surgery in San Diego was pioneered. Additional transplant services include kidney and pancreas. Sharp Mary Birch Hospital for Women & Newborns is also part of the Sharp Metro Campus specializing in the unique care of women and newborns. It provides advanced care for high risk pregnancies and a NICU which is recognized as one of the world's best.

Sharp Chula Vista Medical Center is a 449 bed facility located in San Diego South Bay. It offers advanced cardiac care, including a full range of cutting-edge cardiac treatments. Unique services include bloodless surgery and medicine and skilled nursing facilities. In 2020, a new tower was opened which houses 10 additional critical care and state-of-the-art surgical suites and the region's only hybrid procedure room for advanced cardiovascular procedures.
