





Walgreens and the Campbell University College of Pharmacy & Health Sciences Community Pharmacy Residency Program (PGY1), Durham and Dunn, NC

Walgreens Community Pharmacy Residency Program is a postgraduate training opportunity for pharmacists to enhance their skill set in the community pharmacy setting. The residency is academically affiliated and financially supported, in part, by the Campbell University College of Pharmacy & Health Sciences. This residency will allow the pharmacist to build on their professional skills by providing a variety of patient care services. There are two residency locations one in a more urban setting in Durham, NC and one in rural setting located in Dunn, NC.

Pharmacists in this setting will have a direct influence on patient outcomes through participation in patient counseling, immunization services, health testing services, and Medication Therapy Management with a specific emphasis on patient adherence. Residents will also work to develop collaboration with area providers and develop innovative clinical pharmacy services for patients who are prescribed complex therapies. In Durham there will be a focus on Specialty Pharmacy (HIV, Hepatitis C, Infertility, Transplant, Oncology, and Cystic Fibrosis). In Durn the focus will be on diabetes. The resident will complete a teaching certificate program and will assist in teaching opportunities and precepting experiences for the Campbell University College of Pharmacy & Health Sciences. The residency program graduates will be leaders in the pharmacy community and will have an active role in advancing community pharmacy practice.

Residency Activities

- Development of collaborative programs to improve patient adherence and outcomes
- · Medication Therapy Management
- · Patient counseling
- Assist in delivery of complex medication education
- · Conduct health testing services
- Evaluate the sustainability of new patient care programs
- Enhance existing patient care programs
- · Administer immunizations
- Complete a Teaching Certificate Program
- · Serve as a preceptor to pharmacy students
- Design and conduct a practice based research project
- Present research project findings at a professional conference

- Residents are eligible for Paid Time Off (PTO). The rate at
 which you accrue your PTO will be based on your years of
 service, average hours per week, and position. Resident pharmacists may accrue approximately 15 days depending on average hours worked and time in position.

Candidate Requirements

- Graduation from an ACPE accredited school or college of pharmacy with a Doctor of Pharmacy degree preferred
- North Carolina Pharmacist license within 90 days of the start of the residency program
- Completed on-line application at www.walgreens.jobs
- Submission of residency application materials to Pharmacy Online Residency Centralized Application Service (PhORCAS)
 - Current resume or curriculum vitae, including statement of career goals.
 - Formal letter of intent detailing the candidate's career goals and vision and philosophy of community pharmacy practice
 - · Official transcript of pharmacy coursework
 - Three (3) letters of professional recommendation, one of which must come from an employer or work supervisor.
- Individuals must participate in and adhere to the rules of the Resident Matching Program.
- On-site interview (upon invitation)

Application Process

A completed application and all accompanying materials must be received no later than **January 6**th to be considered for the program.
