

## **Banfield Pet Hospital Recruiting Event Sweepstakes Promotion**

### **Official Rules**

NO PURCHASE NECESSARY TO ENTER

**Overview.** This Banfield Event Sweepstakes Promotion (the “Sweepstakes”) is a promotion sponsored by Medical Management International, Inc., dba Banfield Pet Hospital (“Banfield”) in connection with the following Banfield recruiting event (the “Event”):

New Hampshire Veterinary Technician Association Spring Conference (NHVTA)

**Eligibility.** To be eligible to enter the Sweepstakes, entrants must be a legal U.S. resident and 18 years of age or older. Void where prohibited by law. Employees of Banfield or any entity involved in the production or promotion of the Promotion, and those living in the same household (“Banfield Affiliates”), are not eligible to enter or win.

**Sweepstakes Period.** The Sweepstakes begins on 04/28/2024 at 12:01 am Pacific Time and ends on 04/28/2024 at 11:59 pm Pacific Time (the “Sweepstakes Period”). Banfield’s computer, or its third party service provider’s computer, is the official timekeeping device for the Sweepstakes. **How to Enter.** Completion of either of the following constitutes an “Entry”:

(a) All registered attendees at the Event will be automatically entered in the Sweepstakes; or

**Drawing and Notification.** Each Sweepstakes prize winner will be selected in a random drawing on or about 04/30/2024, from all eligible Entries received during the Sweepstakes

Period. The results of all drawings, and the decisions of Banfield and its third party service providers, are final and binding in all respects. Each winner will be notified by email to the email address provided with entry, within ten (10) business days after the prize drawing. If a potential winner cannot be reached at the address provided and does not respond to Banfield (or its third party service provider) within ten (10) days from receipt of the prize notification, or if the potential winner is found to be ineligible, or if the potential winner cannot or does not otherwise comply with these Official Rules, an alternate winner will be selected by a second chance random drawing.

**Consent to Receive Email.** By participating in the Sweepstakes, you will opt-in to receive email or other communications from Banfield and its affiliated partners. You may subsequently opt-out of the receipt of such email or communications by following the directions in the email. Your opt-out status will not affect your participation or chances to win in the Sweepstakes. During the Sweepstakes Period, however, you may nevertheless receive emails which Banfield deems are related to the Sweepstakes and related programs.
