### Federal Project Director (FPD)

Apply to either the [General Engineer](#) or [Physical Scientist](#) posting

- The successful FPD candidate will provide leadership, guidance and direction in the planning, design, construction and start of operations of various complex facilities and scientific experiments/projects. These exciting projects will lead to discoveries and breakthroughs in fundamental particle and basic energy science that support DOE’s mission in national security and energy independence of the nation.
- The candidate will also provide oversight of various construction activities at BNL; engage in mandated sustainability requirements and assist in various facility data calls and data validation.
- Applications and resumes must support the candidate’s experience in design and construction of buildings, systems, and experimental facilities. It must also demonstrate project management experience in executing a project from inception to completion.
- A working knowledge of various building codes and their applicability to projects, as well as experience in contractor oversight should be documented in the application/resume.

### Facility Representative (FR)

- A successful candidate will serve as line management’s on-site technical representative for identifying and evaluating environmental, safety, and health issues and concerns at DOE SC mission-critical research and support facilities at Brookhaven National Laboratory.
- The candidate plays an essential role in operations communication between the facility contractor and DOE management. S/he must be able to work independently, express safety and engineering feedback verbally and in writing at all working levels; recommending both short-term compensatory measures and ultimate solutions to DOE SC management.
- Applications and resumes should support the candidate’s experience in performing field assessments in research laboratories, construction projects and complex facilities such as utilities, accelerators, power plants, nuclear operations, and material or waste processing.
- The candidate should have experience applying industrial facility and worker safety standards, such as OSHA, NFPA and building codes, to operations.
- A working knowledge of DOE requirements and experience in contract oversight is a strength.
