Deluxe's employee assistance program (EAP) provider, Magellan, offers an expanded portfolio of behavioral and specialty health solutions to support wellbeing. The EAP provides support on a wide range of needs. Although this list is not exhaustive, some examples include:

- This benefit is provided by Deluxe at no cost to you.
- The EAP is available to you and your household members.
- Help is available 24 hours a day, 7 days a week, 365 days a year. At any time, day or night, weekends and holidays, you will be able to speak with one of Magellan's licensed clinicians.
- Access includes five (5) counseling sessions per member, per issue, per year.
- The service is completely confidential.

You Shine

The purpose of the Deluxe You Shine program is to acknowledge and reward those employees who have exhibited the behaviors and demonstrated the core values of Deluxe. Recognition makes us all feel valued, engaged and appreciated for our contributions in helping make Deluxe a great company.

The program is open to all levels of employees for both receiving and giving recognition. All regular Deluxe employees are eligible to participate in this program. To receive recognition awards, eligible employees selected for recognition must be employed by the company at the time the awards are distributed.

Gympass

Gympass is a discovery platform that helps you stay active anytime, anywhere! With a single membership, you get access to livestreamed classes, virtual 1:1 personal training and wellness apps, and on-demand workouts. Flexible month-to-month memberships have no contracts, initiation fees or cancellation fees. Upgrade, downgrade or pause your plan at any time.

Tuition Assistance

The Deluxe tuition assistance program supports continuous learning by offering financial assistance to employees, administered by Alight.

Full-time employees who are regularly scheduled to work thirty-two (32) hours or more per week may receive tuition reimbursement up to \$5,250 per calendar year.

Part-time employees who are regularly scheduled to work at least twenty (20) hours but fewer than thirty-two (32) hours per week may receive tuition reimbursement up to \$2,625 per calendar year.

Travel Assistance

Deluxe offers free travel assistance to employees for personal travel.

Access pre-trip planning and emergency services, including:

- Information on passports, visas and immunization requirements
- Updated currency conversion information
- Medical relocation and medical or security evacuation
- Identity theft support if your wallet or purse is lost or stolen
- · Assistance replacing lost or stolen luggage or other critical items
- · Repatriation of mortal remains

Medically necessary repatriation: Following an illness or accident requiring a traveling member to obtain further medical treatment or to recover, if medically necessary, Redpoint shall arrange and pay (up to \$150,000) for repatriation of the traveling member to a medical facility or permanent home residence.

Mortal remains repatriation: Redpoint will provide, arrange and pay (up to \$50,000) for reasonable expenses related to transporting a travel member's mortal remains from a morgue or hospital to a morgue, funeral home or mortuary designated by such family member within the United States.

Making a Difference

Deluxe Corporation Foundation

The Deluxe Corporation Foundation focuses on long-term solutions that help people, businesses and communities thrive and grow. Since 1954, the foundation has awarded \$109 million to charitable organizations.

Employee Giving Program

Most employee donations are matched dollar-for-dollar by the Deluxe Corporation Foundation up to \$2,000 each year on behalf of each employee. Many sites coordinate fundraisers and/or direct-service projects to align with the campaign. Our employee giving portal is philanthropycloud.com.

Employees who donate fifteen (15) hours of their time to a nonprofit organization of their choice may qualify for a \$200 match (up to two [2] matches per employee per year). Employees who serve on a nonprofit board of directors and donate forty (40) hours of their time can request one (1) \$500 match per year.

Deluxe Volunteers

Volunteering in the communities where we work and live is important to Deluxe and our employees. Volunteering provides a greater sense of community and brings us together to make an impact outside of our normal workplace. Deluxe communities coordinate their own community projects, which include:

- On-site blood drives
- Fundraisers to benefit a variety of charities
- School supply and food drives
- · Purchasing holiday gifts for disadvantaged families
- Volunteer paid time off for 2021 all regular North American employees receive twenty-four (24) hours of volunteer time off (VTO) to be used annually

W.R. Hotchkiss Foundation Scholarship Program

The W.R. Hotchkiss Foundation Scholarship Program awards scholarships to qualifying dependents of Deluxe employees and qualified retirees. This is a generous scholarship program in which 25% of all applicants receive scholarships. These are renewable scholarships that are limited to the first four (4) years of undergraduate studies. Students working toward vocational, associate or undergraduate degrees are eligible. The Annual Hotchkiss Scholarship application process will run each year from early December to January. This is a separate nonprofit organization, and all funds are donated by Deluxe retirees and family members.

Volunteer Time Off

- VTO can be utilized for non-worksponsored volunteer opportunities.
 The time can be taken in the same increments that PTO can be requested (15-minute increments for hourly or half days for salaried).
- VTO requires approval from the employee's manager, and adequate notice must be given when submitting the time off. VTO does not roll over from year to year and is not paid out if an employee leaves Deluxe.
