



**OFFICIAL RULES
GREAT CLIPS® THE 2020 GREAT GIVEAWAY**

Great Clips, Inc. is sponsoring a series of events hosted by some of its franchisees at cosmetology schools in the U.S. and Canada to meet up and coming cosmetology professionals (including, but not limited to the Great Clipper, Great Career and Culture45- From Student to Professional, The Healthy Stylist, and Finance: Earn, Aim and Accomplish events). Attendees who register at a 2020 event listed above and who become part of the Great Clips® Online Talent Community (the “Stylisthood®”) may be eligible to win one (1) of fifteen (15) prizes, as determined in each of three (3) separate drawings (each, an “Entry Period”) as outlined below.

1. ELIGIBILITY

The Great Giveaway (“Event”) is open to U.S. or Canadian residents that have reached the age of majority in their state or province of residence (but no less than 18 years of age), who attends a 2020 event listed above, and meets all requirements and obligations of these Official Rules. - The second Entry Period begins at 12:00 a.m. CST on June 1, 2020 and ends at 11:59 p.m. CST on July 31, 2020.
- The third Entry Period begins at 12:00 a.m. CST on September 1, 2019 and ends at 11:59 p.m. CST on October 31, 2020.

Sponsors are not responsible for incomplete or incorrect registrations or lost, illegible, incomplete, unconfirmed, damaged, late or misdirected entries, all of which will be void. Additionally, Sponsor is not responsible for any technical malfunctions of computer online systems, computer equipment, software, program malfunctions or other failures, delayed computer transactions or network connections that are human, mechanical or technical in nature, or any combination thereof that affect entries. Sponsor reserves the right, in its sole discretion, to disqualify any individual found to be tampering with the entry process or the operation of the entry; to be acting in violation of these rules; or to be acting with intent to annoy, abuse, threaten or harass any other person. 4. PRIZES AND WINNER SELECTION

Fifteen (15) winners will be selected by random drawing at the conclusion of Entry Period 2 (on or about the 15th day of the month following the end of the applicable Entry Period) to receive a \$75 USD gift card from American Express (or similar card issuer in the discretion of Sponsor), a Clipper Caddy valued at \$15 USD, and a Feather razor and blades valued at \$54 USD. Fifteen (15) winners will be selected by random drawing at the conclusion of Entry Period 3 (on or about the 15th day of the month following the end of the applicable Entry Period) to receive a \$75 USD gift card from American Express (or similar card issuer in the discretion of Sponsor), a Clipper Caddy valued at \$15 USD, and trimmers valued at \$83 USD. Entry Period 3 ARV per Prize: \$173 USD. Total Entry Period 3 ARV: \$2,595 USD.

Prizes will be mailed using the name and address provided by the winner upon receipt of notification and provision of a valid mailing address.
