The Full-Time FLDP is a two-year program designed to cultivate future leaders for MMC Global Finance. - Interested in the Risk and Insurance Services and Consulting industries

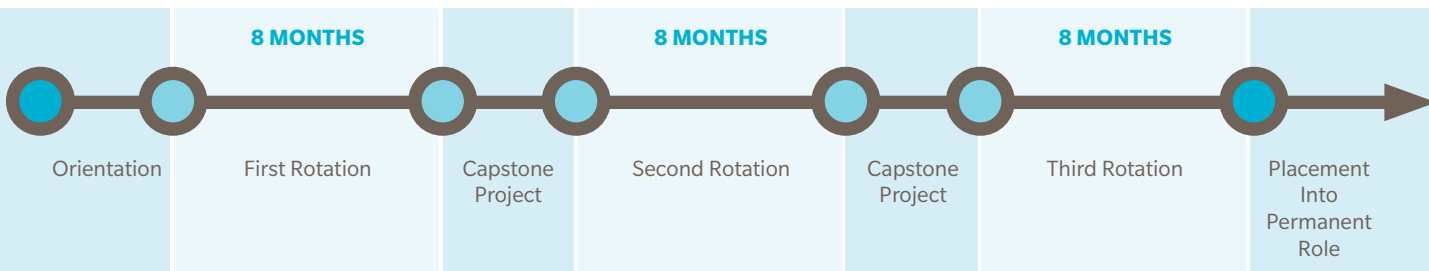
