*Our mission is to bridge the gap from Nurse Practitioner Academia to Practice by providing additional clinical education, classroom education and mentorship.*

Hackensack Meridian Health is proud to be one of the first Primary Care Nurse Practitioner Residency/Fellowship Programs in New Jersey. In partnership with our academic partner, Monmouth University, we have created a rigorous nurse-practitioner residency program in community-based primary care practices in NJ Counties of Atlantic, Monmouth, Ocean, Middlesex and Bergen.

This program is a one-year, full time commitment designed to provide the new NP Clinician with a unique educational opportunity to focus on clinical experience in outpatient primary care, specialty medical practices, psychiatry and urgent care centers specific to the Nurse Practitioner’s Population Foci. Didactic sessions will supplement the clinical experience with Case Study Presentations, quality improvement projects, journal club, SIM skills lab and lectures to provide both personal and professional growth.

## APPLICANT QUALIFICATIONS

- U.S. Citizen
- Graduate of Commission on Collegiate Nursing Education (CCNE) or the Accreditation Commission for Education in Nursing (ACEN) accredited nurse practitioner programs.
- Graduated on or after January 1, 2020.
- Agree to full time participation in HMH GNPRP for 12 months.
- Hold a master's degree or doctorate in Nursing and be licensed as a nurse practitioner in New Jersey, nationally board certified through the ANCC or ACNP with a specialty in Adult/ Geriatric, Family or Psychiatric-Mental Health with focus on primary care.
- Proficient in written and spoken English, bilingual preferred.

## APPLICATION REQUIREMENTS

- Curriculum Vitae and official graduate school transcripts.
- Personal statement describing what led you to become a nurse practitioner and any professional organizational activities. What are your goals and expectations from a residency program? What are current challenges in health care and how can you impact change?

- Copy of Malpractice Insurance Declaration Page
- NJ APN License, Federal DEA and NPI.  
National board certification as a Family, Adult/ Geriatric or Psychiatric-Mental health NP.
- Three (3) letters of professional reference.

## BENEFITS

- Full time position at Hackensack Meridian Health for one year.
- A comprehensive benefit package that includes paid vacation, sick leave, holidays and health benefits.
- One-year residency will count as one year of experience as a nurse practitioner. Upon successful completion of the program, residents will be given the opportunity to apply to available vacancies at Hackensack Meridian Health primary care and/or mental health practices.

## PROGRAM STRUCTURE

- This is a paid 12-month residency.
- Clinical rotations are supplemented with didactic sessions, Case Study Presentations, Journal Club and other learning experiences.
- Didactic sessions weekly with expert content providers provided through Hackensack Meridian Health as well as Monmouth University School of Nursing.
- Assigned Clinical Rotations in primary care, behavior/ mental health, urgent care or pediatric sites. Residents are assigned a mentor to act as a resource and provide support as they transition to autonomous nurse practitioners.
- Applicants should have a desire to work in primary care, mental health, FQHCs or other safety settings within underserved communities.
- Upon successful completion of the residency, a certificate of completion is awarded.
